### **Central Ave Improvements Overview**

Dorchester County proposes roadway widening and improvements along Central Ave from Orangeburg Rd to Parsons Rd. Two alternatives, are being evaluated to include the following:

Alternative 1: 3-Lanes from Orangeburg Rd to W Butternut Rd & 5-Lanes from W Butternut Rd to Parsons Rd.

Alternative 2: 5-Lanes from Orangeburg Rd to Parsons Rd.


The proposed roadway sections will also include curb and gutter, enclosed drainage, shared use path, sidewalk, and associated improvements. The Project Study Area extends along Central Ave for approximately 2.8 miles through the Town of Summerville. SC.

## **Parsons Rd Improvements Overview**

Dorchester County proposes roadway widening and improvements along Parsons Rd from Central Ave to W Richardson Ave. One 3-lane alternative is being evaluated. The proposed roadway section will also include curb and gutter, shared use path, sidewalk, enclosed drainage, and associated improvements. The Project Study Area extends along Parsons Rd for approximately 1.37 miles through the Town of Summerville, SC.


